Theology and the Local Church in the Holy Land Conference (Palestinian Contextualized Theology Conference)

FROM FASTING TO EASTER: A CHURCH VISION IN GALILEE

2 February 2008, Mar Elias Institutions – Ibillin, Galilee



On the 2nd of February 2008, the Theology and the Local Church in the Holy Land Conference was organized by Al-Liqa' Center/Galilee Branch. The conference took place at Mar Elias Institutions in Ibillin, titled "From Fasting to Easter: A Church Vision in Galilee". The conference was inaugurated with a Biblical meditation and reflection by Rev. Fu'ad Dagher, pastor of the Evangelical Church in Shafa 'Amr. He stressed the importance and spiritual meaning of fasting. Dr. Geries S. Khoury gave the first lecture in which he put forth the issue of fasting in the Bible and fasting's history in early

Christian eras and among the eastern fathers of the church. Dr. Khoury pointed out as well fasting in Christian Arab heritage in the Middle Ages and among

a number of theologians and philosophers.

Following a lunch break a panel comprising Bishop Dr. Elias Chacour, the head of the Melkite Catholic Church in Galilee and Bishop Dr. Boulous Marcuzzo, the Latin Vicar in Nazareth took place Bishop Elias Chacour said that the greatest love is when a person himself sacrifices to his neighbor. This is the teaching of Christ. I send my appeals to all faithful not to

aggress against their fellow brothers. Concerning Christian presence in the Holy Land, Bishop Chacour refuted all those who classify Christians in the land as a minority. They are an integral part of their people. Jews in the United States refuse their classification as a minority. Instead, they consider themselves as a community.

Bishop Marcuzzo questioned the presence of cultured Christians in public life and he called for attracting them to such positions. He added that the Church in our land is committed to renewal of faithful's life through the general Parish Plan. Faithful must renew himself/herself from the inside through prayer, parish work and fasting. Bishop Marcuzzo added that fasting is not an end by itself. It is a mean and essence and not outside appearance. He gave examples from texts on fasting derived from Christian Arab Heritage.

Dr. Johnny Mansour, a researcher and lecturer in Galilee, pointed out in his lecture, the spiritual and the popular traditions of Easter at different levels: families, young peoples, groups and children. These traditions are on the verge of extinction. At the conclusion of the conference, Dr. Boutros Dalleh delivered a poem, composed on the occasion

of the beginning of the 40-day of fasting, and thanking in the process Al-Liqa' Center.

Dr. Geries Khoury, in addition, read the final communiqué of the conference which is directed to the leaders of the Church in the Holy Land: To allocate scholarships for researches and university students in the areas



of theology and Christian Arab Heritage; to uncover Christian Arab History, to study manuscripts located in international and local libraries such as the Vatican Library, Palestinian, Lebanese, Syrian, and Egyptian monasteries which show clearly the role of Arab Christians and their contribution to Arabic civilization and humanity. This will only strengthen Christian Arab identity and the spirit of belonging to the land, nation and history.

in promoting dialog and in strengthening and deepening "life together" among Palestinian Christians and Muslims despite the very difficult circumstances that Palestinians experience under the Israeli military occupation and practices. Furthermore, he condemned the destruction of the YMCA library in Gaza, which took place few hours before the Jubilee Celebrations were taking place. He dismissed as marginal voices, such as the one of an American senator, who claims that Muslims persecute Christians in Palestine. His Beatitude likewise reiterated that present Palestinian friction into Gaza and West Bank entities must end soon since this division only serves the interest of the occupier. As far as the march of the Center, he stressed the need to broaden the base of Al-Liqa', to reexamine Palestinian educational curricula, especially in religious education, and to carry indepth studies and research work on Muslim-Christian relations.

The Patriarch was followed by Dr. Geries S. Khoury, the Director of Al-Liqa', who briefed the audience on the accomplishments of the Center in the last twenty five years. He talked with similar organizations in the Islamic world and mentioned





the "Qatar Interfaith Forum" and possible relations with them in the near future. Professor Thiab Ayyoush, Vice President of Al-Liqa Board, stressed that uniqueness of Al-Liqa' Center which was the first of its kind in the area of interfaith dialog and in the Arab nation. The success of Al-Liqa' encouraged other similar centers in Lebanon, Cairo and Amman. The Center underlined national partnerships, and held conferences and panels and participated in international conferences such as the International lerusalem Forum which was held in Istanbul from 14-17 November 2007. He also mentioned the importance of research in the future. The person in charge of external affairs in MISSIO-Aachen, Germany, Mdm. Irmgard Icking, who came specifically to attend Al-Liqa' Silver Jubilee expressed her happiness for attending the celebration. MISSIO has supported Al-Liqa' all those years hoping that this support contributed to the proliferation of "shared living" among Palestinians as well as the development of "Palestinian Contextual Theology". Dr. Harald Suermann and Dr. Richard Brosse from the Missiology Institute and other colleagues in "MISSIO- Aachen" extend their best wishes and continued support to Al-Liqa' Center. Dr. Uwe Grabe, the Propst of the Evangelical Lutheran



Church, Jerusalem, said that Al-Liqa' Center is different from many dialogue-initiatives, which sprung up from the ground of Palestine and Israel like mushrooms during

Dr Khoury spoke also about the future vision of Al-Liqa Center. He thanked in the process all those who supported Al-Liqa' from the local community by their continuous presence and contributions, and thanked all Catholic and Protestant organizations, locally and internationally, for their financial support and in a special way he thanked "MISSIO-Aachen" for its unique support since al-Liqa was established in 1982. Dr Khoury thanked warmly the members of the

Board of Trustees and all those who worked and still in Al-Liqa and the Emerezian Est. Jerusalem. At the end of his speech, Mr. Osama Emerezian presented to Dr. Khoury a plaque congratulating Al-Liqa' Center on the Silver Jubilee. Following Dr. Khoury, there was a video presentation of Al-Liqa' Center.



The Chief Muslim Religious Judge of Palestine, His Eminence Sheikh Tayseer Al-Tamimi, stressed in his speech the Muslim-Christian solidarity and the important role of all Palestinians in defending and preserving the Holy city, Jerusalem from the Israeli occupation. Sheikh Tamimi spoke also about the importance of the Omar treaty and about citizenship and freedom for all. He remembered George Habash who was a dear friend to his father. Sheikh Tamimi mentioned also the importance to have strong relations the years of the Oslo Process and which soon succumbed, while the work of Al-Liqa' is deeply rooted in its Palestinian environment. At the conclusion of the Celebration, certificates of appreciation and medallions were presented to The Chief Muslim Religious Judge of Palestine, His Eminence Sheikh Dr. Tayseer Al-Tamimi and to the founding members of the Board of Trustees and other members of the Board. A special plaque and certificate of appreciation was presented by H.B. Patriarch Sabbah and the Director of Al-Liga, Dr. Geries S. Khoury, to the representative of MISSIO-Aachen, Mdm. Irmgard Icking. During the celebrations traditional dance and songs were presented by "Arabella" and "Dalal" musical group.

At the conclusion of celebrations everyone attending was invited for a special dinner at which several persons spoke including Dr. Amal Jado, Attorney 'Ali Rafe', and Al-Liqa' Board member, Mrs. Hanadi Soudah Younan. All of them spoke about their experiences in Al-Liqa' during the years present and past. Likewise, a hard cover bi-lingual Al-Liqa Silver Jubilee (1982-2007) was distributed to all attendees.



Wednesday Evening Forum

Bethlehem 10 April 2008,4.30 p.m

Al-Liqa' Center hosted Mrs. Rawiya Shanti of Galillee who spoke on "the uprooted Palestinians in Israel." Following a brief historical introduction, the lecturer focused on the laws that were promulgated by the Israelis to displace Palestinians within Israel and the

expropriation of Arab Lands leaving Arab towns and village with little land. Resistance against these measures began as a result. Detailed discussion ensued.

Bethlehem 7 March 2008,5:00 p.m.

Professor Aziz Haidar was the guest speaker in the forum. He focused on "The current situation in Israel and opportunities for a political solution." Professor Haidar pointed out the centrality of "security" in the making of Israeli policies. Israeli failures in the 2006 Lebanese war proved the failure of these policies despite a viable and growing economy. Professor Haidar, in addition, explored controversies in the social and political situations in Israel.

Bethlehem 7 March 2008,6:00 p.m.

Guest speaker in the forum was Dr. Geries S. Khoury, Director of Al-Liqa' Center, He focused on "Christian Arab role in Arab and Islamic history

and their contributions to Arab/Islamic renaissance in the Middle Ages."

He stressed present and future march of the local church and its qualitative presence in society despite the constant bleeding of the phenomenon of emigration.

In his lecture on Christian Arabs and challenges that face them, Dr. Geries S. Khoury, Director of Al-Liqa' Center, focused on "Christian Arab's role throughout history. He spoke of Christian and Arab ignorance of their role in history, negative Islamic reaction to Western attitudes and policies toward Islam, the unjust Israeli policies toward Arabs in general and Christians in particular and the need of steadfastness of Christian Arabs in light of the dangerous phenomenon of emigration.

REFLECTIONS ON THE 60TH REMEMBRANCE

OFTHE 1948 PALESTINIAN NAKBA (Disaster)

Despite the Universal Declaration of Human Rights/1948, UN General Assembly Resolution 1947/1948, The Fourth Geneva Convention/ 1949, European Convention for the Protection of Human Rights and Fundamental Freedoms Protocol/1963, UN Security Council Resolution 237/1967, UN General Assembly Resolution 2672/1970, among others, all of which call for the return of displaced persons to their homes, the 1948 and 1967 refugee problem has not been solved. In this year in which we commemorate the 60 years of the 1948 debacle, the 750,000 refugees who were uprooted and displaced in 1948 are numbering now at 5.5 million. Israel shows no interest in solving this refugee problem on security and demographic grounds. And as long as the Palestinian problem is not solved and complete





recognition is not accorded to the plight of the Palestinian refugees in the West Bank, the Gaza Strip and the world wide Diaspora, there will be no settlement of the Arab Israeli conflict. Unfortunately, bloodletting will continue unabated. The remembrance of the Nakba, on the other hand, should give Palestinians in Palestine and the Diaspora further impetus to study past mistakes so that they do not commit them again. This remembrance should renew them the hope for a better future, for themselves and their posterities, at which time Palestinian society will become the model for other societies, a model that is based on national unity democracy and total social justice in society. I hope this is not a mere dream or a/wishful thinking but a practical future vision.

Al-Liqa's International Activities

Dr. Geries S. Khoury participated in the 3rd session of the conference and "Coexistence & Peace Making" which was sponsored by the Jordanian Interfaith Coexistence Research Center, 22-23 January 2008, in Royal Convention Center in Jordan's capital Amman.

Topics addressed and discussed include coexistence and understanding the other, the experience of Al-Nour Center. The Jerusalem experience, the coexistence message and peacemaking and coexistence and peacemaking: lessons and tool. Participants signed the Christian Muslim Declaration of Coexistence; in the final statement the conference stressed "the shared living" and the quest for a comprehensive and just peace.

It stressed as well freedom of religion and dogma

and the dire need to pursue interfaith dialogue.

A visit of the American Council of Young Political Leaders

A delegation comprising members of the American Council Of Young Political Leaders led BY Cass Burton, attorney, Department of Insurance, Texas visited Al-Liqa' on Monday 16 june 2008. Dr. Geries S. Khoury, Director of Al-Liqa', briefed the delegation on the mission of Al-Liqa'. Other members of the Board of Al-Liqa', Mr. Mousa Darwish, Dr. Abd Al-Rahman 'ABBAD, Ms. Hanadi Soudah Younan, Ms. Makarem Awad and Dr. Adnan Musallam added to the lively discussions that followed. The delegation was accompanied by representatives from the Bethlehem Governorate and the American Consulate in East Jerusalem.
